Sanctum House and it's residents and staff were no different, except for the fact that we were determined the come out of this pandemic healthy, strong, and sane. We did it! We followed the CDC guidelines throughout it all and had a strong Covid policy to follow that was created by our medical director Dr. Jodi Flanders. As of today, we remain free of the disease for both our residents and staff. We maintained most of our programing, adjusted to therapy on Zoom, restricted movement due to shutdowns, and limited ability to have volunteers, and we did it all with grace and style! We hunkered down and became a stronger program and family.

As did most everyone, we lost much of our ability to fundraise with shutdowns, events cancelling, and funds diverted to helping the most immediate needs of Covid patients and first responder organizations. How grateful we are to the institutions that have supported us in the past who came up to the plate and batted a hundred for us. They created food drives, paper goods collections, craft deliveries to keep us busy, and we were able to start a jewelry business to help the women learn a craft, earn some money and contribute to the needs of the house.

The world turned and we got used to doing education and outreach from yellow squares on Zoom to let people know that human trafficking did not stop because Covid started. Women, girls, boys, and men were still falling victim to this heinous crime and we did not want our mission, this movement to fall by the wayside. As we all hunkered down in our private space, somehow we got closer to what is truly important and how much less we needed and how much more important community and love means to all of us.

We are grateful for getting through 2020 and look forward to a fruitful 2021 as we plan to grow through the women we serve, our programing, and a Capital Campaign that has started strong and keeps moving in a positive direction.

VISION: Empower survivors of human trafficking with life skill to achieve a sustainable and independent lifestyle.

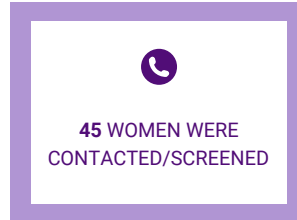
MISSION: To provide a sanctuary for women survivors of human trafficking.

ABOUT US

Sanctum House was Founded in 2013, became a 501(c)(3) in 2015 and after years of research and planning opened its doors February 12, 2018. The house is a refuge for victims of human trafficking, providing one of the most comprehensive programs in the United States. Located in Metro-Detroit, and because of our success, Sanctum House has become a model for other organizations. We strive for excellence in everything we do, and compassion for all who we come in contact with. The journey of our women residents varies and requires a tailor-made program, which we provide. We are hoping to grow our campus and services to help many more adult women in need.

WHAT WE DO

Our up to 24-month residential program for females 18 years of age or older provides wrap around services to address physical, psychological, emotional, educational and spiritual needs necessary to overcome trauma and move towards a happy, healthy productive future. We provide therapy and trauma care, health and wellness resources, educational opportunities, vocational skills and job training. Additionally, through our direct services and partnerships with over 30 key community allies, survivors have access to the services listed below. We also conduct community education and outreach to create awareness about human trafficking in hopes of reaching more victims.

SOME OF OUR RESIDENTS MILESTONES

- In the early part of 2020 two residents started college courses (OCC)
- One resident enrolled in the seminary master's program in Theology.
- One resident received her High School Diploma and participated in her graduation.
- Six residents began working on family reunification.
- One resident traveled to her home state to visit her family and daughter.
- One resident took a family trip with her previously estranged children.
- One resident received support through Wayne County Court with Christmas gifts for her children.
- One resident was able to start Zooming her son in another country. Now on a regular basis.
- One resident re-established a relationship with her adult son.
- We created an annual Friends and Family outing and for our residents and staff at Victory Ranch.
- One resident was formally Baptized into the Catholic faith.
- One resident joined the Catholic Church, participating in all classes/ceremonies associated with this.
- All residents and staff enjoyed an outing at Greenfield Village for the Marvel Exhibit.
- Congresswoman Brenda Lawrence came to Sanctum House and met with the ladies for input about HT
- Two of our residents purchased cars, with cash, after utilizing what they learned through the financial literacy and savings plan taught at Sanctum House.

CAPITAL CAMPAIGN

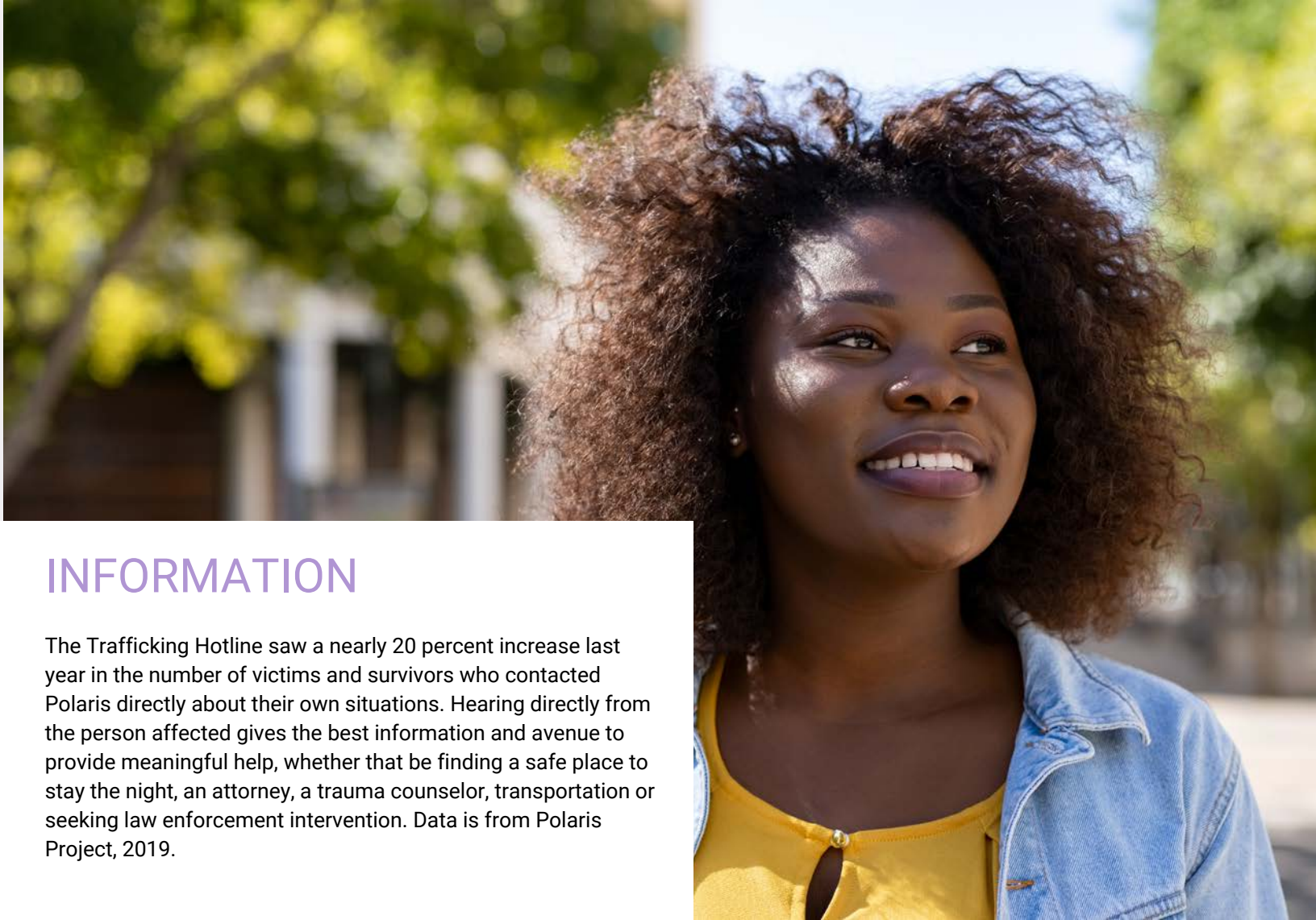

INFORMATION

The Trafficking Hotline saw a nearly 20 percent increase last year in the number of victims and survivors who contacted Polaris directly about their own situations. Hearing directly from the person affected gives the best information and avenue to provide meaningful help, whether that be finding a safe place to stay the night, an attorney, a trauma counselor, transportation or seeking law enforcement intervention. STATISTICS

From January 1 to December 31, 2019 (the most recent data available), the National Human Trafficking Hotline was contacted over 1,500 times in Michigan. The problem is that due to underreporting we know that this number and those on this chart are just a part of the whole picture.
