Who We Are

Sanctum House is Michigan's only comprehensive human trafficking organization providing 24-hour, on-site care and support for women survivors of human trafficking. We help survivors overcome trauma and empower them with the life skills necessary to achieve a healthy, productive and independent life.

What We Do

Our residential program for females 18 years of age or older provides integrated, wrap-around services for up to 24-months. We address the physical, psychological, emotional, educational and spiritual components necessary to overcome trauma and move towards a happy, healthy productive future. Every women's progress is an independent path and success is uniquely measured for each resident. Specifically, we provide therapy and trauma care, health and wellness resources, educational opportunities, vocational skills and job training.

Through our direct services and partnerships with over 30 key community allies, survivors have access to

An Epidemic

Since 2007, The National Trafficking Hotline has reported more than 40,000 substantiated victims of trafficking. In 2017 alone, 8,759 cases of human trafficking were reported to the hotline, which represents a 13% increase in cases compared to 2016. When looking exclusively at sex trafficking the numbers are equally astounding:

- From 2007 to 2017, the National Human Trafficking Hotline, operated by Polaris, has received reports of 34,700 sex trafficking cases inside the United States.
- In 2017, the National Center for Missing & Exploited Children estimated that 1 in 7 endangered runaways reported to them were likely sex trafficking victims.
- The International Labor Organization estimates that there are 4.8 million people trapped in forced sexual exploitation globally.



Our Impact

Since we opened our doors in February 2018, Sanctum House has served as a place of hope and healing for 22 women. Each woman undergoes an intensive trauma treatment program, and when deemed ready, begins a journey of growth and empowerment. To date that has resulted in:

- 1 resident completed her first semester at Oakland Community College
- 1 resident is working on her GED
- 2 residents have found employment
- 2 residents were reunited with their families

In addition to providing housing and life-skills training, Sanctum House also works to put each woman on a path to a productive future. Consequently, we worked with legal partners to eradicate over 27 warrants that were impeding women from gaining employment. Clearing these warrants will result in women getting driver's licenses, identification, jobs, and new identities.

Sanctum House believes in the importance of giving back. With this in mind, each of our residents has the opportunity to donate 8 hours of her time each week to volunteering in the community. To date we have worked with: Gleaners, CARES and Angels, Saints and Stuff.

Through our education and awareness program, we have reached over 200 women's clubs, optimist clubs, philanthropic organizations, schools and universities, religious organizations, 1st responders, city officials and sororities. Each of these groups has learned about the signs of human trafficking and how to spot victims, myths and realities of human trafficking, how to appropriately respond and what services Sanctum House provides. In total, we have reached nearly 8,000 individuals.
